1 RULES

- 1.1 The regatta will be governed by the 'rules' as defined in *The Racing Rules of Sailing*.
- 1.2 The prescriptions of the Italian Sailing Authority (FIV) will apply and will be posted on the Official Notice Board.
- 1.3 The Class Rules of the respective International 49er and 29er Class Associations will apply except any that are altered by the Notice of Race or the Sailing Instructions.
- 1.4 The boats shall keep clear of the Navigarda liners.

2 ADVERTISING

- 2.1 The 49er and 29er are Category "C" Classes in accordance with the ISAF Regulations.
- 2.2 The organising authority may ask competitors to display Event and Class sponsor advertising material. Boats may be asked to carry stickers carrying sponsor advertising provided at registration. These should be attached to the boat in accordance with the instructions provided by the Organiser and displayed in the following areas:
 - Forward 25% of both sides of the hull for Venue Sponsor as per ISAF guidelines.
 - Other advertising as per request from Class and organising committee. This may be on the Jib and main sail.
- 2.3 According to the Italian Law, advertising for alcoholic beverages and for tobacco products is prohibited.

3 ELIGIBILITY AND ENTRY

- 3.1 Competitors shall comply with ISAF Eligibility Rules.
- 3.2 All competitors shall be fully paid-up members of the respective International 49er and 29er Class Associations and a recognized MNA authority.
- 3.3 Eligible boats may enter by completing the attached form and sending it by e-mail to info@vccampione.org or by fax to: +39-0365-1980186.
- 3.4 All sailors under 18 must produce a completed Parent/Guardian consent and declaration attached form. Without a completed form sailors aged under 18 will NOT be allowed to complete registration.

4 SAIL AND BOW NUMBERS

Each boat can be provided by sticker numbers to show as prescript in the S.I. during all the races.

5 FEES

The entry fee is 50 € per boat. Entry fees shall be in Euro and made payable by Cash or Online.

7 MEASUREMENTS

- 7.1 Only one set of sails shall be used throughout the duration of the Regatta. One forestay shall be used.
- 7.2 The Race Committee may inspect or measure any boat at any time.
- 7.3 Equipment shall only be replaced with permission of the Race Committee.

8 SAILING INSTRUCTIONS

The sailing instructions will be available at registration on VCC Secretary.

9 VENUE

9.1 The 4rd MAX SPEED TROPHY for 49er and 29er will be held at Campione del Garda.

10 THE COURSES

All courses will be windward/leeward; a gate at the leeward end of the course may substitute a leeward mark.

11 PENALTY SYSTEM

RRS 44.1 and 44.2 are amended so that the Two-Turns penalty is replaced by a One-Turn penalty, including one tack and one gybe.

12 SCORING

12.1 The Low Points Scoring System will be used.

12.2 2 races are required to be completed to constitute a series.

13 13. SUPPORT BOATS

13.1 Support boats and coach boats will need to register and shall be marked with a numbered identifying flag.

13.2 Support boats and coach boats, if called upon support boats, will be required to act as rescue boats.

14 PRIZES

Prizes to the first 3 boats classified in each Class.

15 DISCLAIMER OF LIABILITY

15.1 A boat is entirely responsible for her own safety, whether afloat or ashore, and nothing, whether in the Notice of Race or Sailing Instructions or anywhere else, reduces this responsibility.

15.2 It is for the boat to decide whether she is fit to sail in the conditions in which she will find herself. By launching or going to sea, the boat confirms that she is fit for those conditions and her crew is competent to sail and compete in them.

15.3 The boat is required to hold adequate insurance and in particular to hold insurance against third party claims in the sum of at least € 1,000,000.

15.4 Nothing done by the organisers can reduce the responsibility of the boat nor will it make the organisers responsible for any loss, damage, death or personal injury, however it may have occurred, as a result of the boat taking part in the racing. The organisers encompass everyone helping to run the race and the event, and include the organising authority, the race committee, the race officer, patrol boats and beachmasters.

15.5 The provision of patrol boats does not relieve the boat of her responsibilities.

15.6 The fact that the race committee conducts inspections of a boat does not reduce the responsibilities of the boat set out in this paragraph. Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

I declare that I hold 29er-49er Membership, Measurement Certificate for my boat, and Third Party Insurance for a minimum liability of Euro 1,000,000, and will produce these on request.

I accept the Conditions of Entry which are that the safety of a boat and its entire management, including insurance, shall be the sole responsibility of the owner/competitor racing the boat, who undertakes to ensure that the boat and its crew are adequate to face the conditions that may arise in the course of sailing in this event. Neither the sailing instructions, nor any inspection of the boat or its crew limits or reduces the absolute responsibility of the owner/competitor for his or her crew and boat and the entire management thereof. The race organisers shall not be responsible for any loss, damage, death or personal injury however caused to the owner/competitor or crew as a result of their taking part in a race or races. Moreover, every owner/competitor warrants the suitability of his or her boat for the race or races and is solely responsible for his or her decision whether or not to sail and compete in the weather conditions prevailing at the time.
